The College has initiated ICT based teaching process. The college has strengthened the Science Laboratories by purchasing necessary equipments. The Library Automation has been partially completed. <p>Suggestions: The college needs to:</p> <ul style="list-style-type: none"> Enrich Science Laboratories in Physic, Chemistry, Maths & Biology. Initiate linkages/collaborations with industry and research institutions. Equip library with more books and other facilities. Strengthen research and placement cell. Promote Sports, Cultural & Extension Activities Enrich research laboratories in Chemistry. Up-gradation of Central Library. Start PG courses in Physics, Botany & Zoology.
6	Recommendation of the Committee	<p>Committee recommends:</p> <ol style="list-style-type: none"> The remaining 10% of CPE grant may be released subject to submission of audited statement of expenditure along with utilization certificate of previous installments of CPE grant. The College is recommended for Phase-II of CPE grant subject to the condition that it is Re-accredited by NAAC at 'A' level. The college is not recommended for CE status even though the college secures NAAC 'A' grade with more than 3.5 CGPA.






